2. Is this (SFY 2025 Call for Projects) for city water/reservoir projects only, or are drilled wells at schools, town halls, shelters and fire department included?

**Answer:** The Drinking Water State Revolving Fund (DWSRF) can only provide financing to community and non-profit non-community public water systems. Towns may own and operate small on-site drinking water systems at their public schools or other municipal complexes. Non-profits' small drinking water systems that are regulated by the Department of Public Health as a non-community public water system can utilize the DWSRF. The use of the DWSRF would be limited to infrastructure improvements that addresses drinking water public health protection (i.e. water treatment upgrades), compliance with State and Federal drinking water regulations or the replacement or rehabilitation of aged drinking water infrastructure. Fire protections projects at these complexes would not be eligible for DWSRF financing.
