Governor Dannel P. Malloy signed the following legislation of the 2015 Regular Session, on June 5th.

- HB 6671 AN ACT CONCERNING THE LEGISLATIVE COMMISSIONERS' RECOMMENDATIONS FOR TECHNICAL
PA 15-18 AND MINOR REVISIONS TO THE GOVERNMENT ADMINISTRATION STATUTES.
This bill has various effective dates. [Refer to the text here.](#)
- SB 290 AN ACT CONCERNING PATIENT-DESIGNATED CAREGIVERS.
PA 15-32 This bill shall effect on October 1, 2015.
- SB 458 AN ACT CONCERNING THE MATURITY DATE FOR MUNICIPAL BONDS ISSUED IN CONJUNCTION
PA 15-33 WITH CERTAIN LOANS FROM THE UNITED STATES DEPARTMENT OF AGRICULTURE.
This bill shall take effect from passage.
- SB 856 AN ACT CONCERNING LANGUAGE INTERPRETERS IN HOSPITALS.
PA 15-34 This bill shall effect on October 1, 2015.
- SB 866 AN ACT CONCERNING THE LEASING OF LIGHTHOUSE BOTTOMLANDS.
PA 15-35 This bill shall take effect from passage.
- SB 893 AN ACT EXTENDING COST REPORTING DEADLINES FOR LONG-TERM CARE FACILITIES
PA 15-36 This bill shall take effect on July 1, 2015.
- SB 898 AN ACT CONCERNING PROFESSIONAL DOCTORAL DEGREE PROGRAMS.
PA 15-37 This bill shall take effect on July 1, 2015.
- SB 940 AN ACT CONCERNING THE SUSTAINABILITY OF THE NITROGEN CREDIT EXCHANGE PROGRAM.
PA 15-38 This bill shall take effect from passage.
- SB 258 AN ACT CONCERNING INFANT SAFE SLEEP PRACTICES.
PA 15-39 This bill shall effect on October 1, 2015.

- SB 287 AN ACT CONCERNING A STUDY OF ALTERNATIVE FUNDING SOURCES FOR NUTRITIONAL SERVICES FOR SENIOR CITIZENS.
PA 15-40 This bill shall take effect on July 1, 2015.
- SB 502 AN ACT CONCERNING BICYCLE SAFETY.
PA 15-41 This bill shall take effect on July 1, 2015.
- SB 509 AN ACT REGULATING THE TOWING OF MOTOR VEHICLES, THE USE OF WHEEL-LOCKING DEVICES AND THE REPOSSESSION BY LENDING INSTITUTIONS OF MOTOR VEHICLES.
PA 15-42 This bill shall effect on October 1, 2015.
- SB 849 AN ACT CONCERNING THE DISCLOSURE OF LEASES OR CONTRACTS WITH QUASI-PUBLIC AGENCIES AND THE NAMES OF SECURITIES IN STATEMENTS OF FINANCIAL INTEREST.
PA 15-43 This bill shall take effect January 1, 2016.
- SB 906 AN ACT ADDING THE COMMISSIONER OF VETERANS' AFFAIRS TO THE CRIMINAL JUSTICE POLICY ADVISORY COMMISSION.
PA 15-44 This bill shall effect on October 1, 2015.
- SB 925 AN ACT ESTABLISHING A HOME VISITATION PROGRAM CONSORTIUM.
PA 15-45 This bill shall take effect from passage.
- SB 936 AN ACT CONCERNING THE DEPARTMENT OF MOTOR VEHICLES' RECOMMENDATIONS WITH RESPECT TO AUTOCYCLES AND THREE-WHEELED MOTORCYCLES.
PA 15-46 This bill shall take effect on July 1, 2015.
- SB 988 AN ACT UPDATING THE OCCUPATIONAL HEALTH CLINICS STATUTES.
PA 15-47 This bill shall effect on October 1, 2015.
- SB 967 AN ACT CONCERNING REVISIONS TO THE CONNECTICUT BUSINESS CORPORATION ACT, THE UNIFORM LIMITED PARTNERSHIP ACT AND THE CONNECTICUT LIMITED LIABILITY COMPANY ACT.
PA 15-48 This bill shall effect on October 1, 2015.
- SB 998 AN ACT CONCERNING PRESCRIPTION DRUGS.
PA 15-49 This bill shall effect on October 1, 2015.
- SB 1022 AN ACT CONCERNING REQUIREMENTS FOR FACILITIES THAT COMPLETE MEDICARE OR MEDICAID APPLICATIONS FOR PATIENTS.
PA 15-50 This bill shall take effect on July 1, 2015.

As of this date, the Governor has signed fifty three (53) bills and vetoed one (1) bill of the 2015 Legislative Session.
