Governor Dannel P. Malloy signed the following legislation of the 2015 Regular Session on July 6th.

- HB 6283 AN ACT REGULATING ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS.
PA 15-206 This bill shall take effect October 1, 2015.
- HB 6498 AN ACT CONCERNING EVIDENCE IN SEXUAL ASSAULT CASES.
