Governor Dannel P. Malloy signed the following legislation of the 2015 Regular Session on June 22<sup>nd</sup>.

- SB 914 AN ACT CONCERNING AN EMPLOYER'S FAILURE TO PAY WAGES.  
PA 15-86 This bill shall take effect October 1, 2015.
- SB 467 AN ACT CONCERNING THE FACILITATION OF TELEHEALTH.  
PA 15-88 This bill has various effective dates. [Refer to the text here.](#)
- SB 569 AN ACT CONCERNING SMALL COMMUNITY WATER SYSTEMS.  
PA 15-89 This bill shall take effect from passage.
- SB 573 AN ACT CONCERNING VARIABLE ELECTRIC RATES.

- SB 855 AN ACT CONCERNING REPORTS OF NURSE STAFFING LEVELS.

PA 15-97 This bill shall take effect July 1, 2015.
- HB 6773 AN ACT CONCERNING LICENSURE REQUIREMENTS FOR REAL ESTATE BROKERS.  
PA 15-98 This bill shall take effect July 1, 2016.
- HB 7019 AN ACT CONCERNING THE MINIMUM BUDGET REQUIREMENT.  
PA 15-99 This bill shall take effect July 1, 2015.
- SB 186 AN ACT CONCERNING THE PENALTY FOR VIOLATION OF A MUNICIPAL  
PA 15-100 ORDINANCE REGULATING THE OPERATION OR USE OF A DIRT BIKE OR ALL-  
TERRAIN VEHICLE.  
This bill shall take effect October 1, 2015.
- SB 862 AN ACT CONCERNING STATE PAYMENT TO CERTAIN FACILITIES FOR RESERVED  
PA 15-102 BEDS.  
This bill shall take effect from July 1, 2015.
- SB 870 AN ACT CONCERNING THE DUTIES OF ANIMAL CONTROL OFFICERS.  
PA 15-103 This bill shall take effect October 1, 2015.
- SB 158 AN ACT CONCERNING LANDSCAPE ARCHITECT LICENSES.  
PA 15-104 This bill shall take effect from passage.
- SB 1061 AN ACT CONCERNING THE FISCAL SUSTAINABILITY OF STATE PARKS.

- SB 1098 AN ACT CONCERNING TEACHER CERTIFICATION REQUIREMENTS FOR SHORTAGE  
PA 15-108 AREAS, INTERSTATE AGREEMENTS FOR TEACHER CERTIFICATION RECIPROCITY,  
MINORITY TEACHER RECRUITMENT AND RETENTION AND CULTURAL  
COMPETENCY INSTRUCTION.

- SB 1114 AN ACT CONCERNING THE COMMISSION ON RACIAL AND ETHNIC DISPARITY IN  
PA 15-109 THE CRIMINAL JUSTICE SYSTEM AND THE REMOVAL OF THE TERMS "CRIPPLED"  
AND "DEFECTIVE EYESIGHT" FROM THE GENERAL STATUTES.  
This bill shall take effect October 1, 2015.
- SB 253 AN ACT CONCERNING PAYMENT TO AN AMBULANCE SERVICE.  
PA 15-110 This bill shall take effect October 1, 2015.
- SB 928 AN ACT ESTABLISHING A SHARED CLEAN ENERGY FACILITY PILOT PROGRAM.  
PA 15-113 This bill shall take effect October 1, 2015.

As of this date, the Governor has signed one hundred ten (110) bills and vetoed one (1) bill of the 2015 Legislative Session.
