OFFER IN COMPROMISE

In accordance with §30-6-A8a of the Regulations of Connecticut State Agencies, Bb Washington Street LLC d/b/a Johnny Utah's ("Respondent") hereby petitions the Department of Consumer Protection to accept an offer in compromise ("Offer") in the amount of a **90 day suspension to be served April 20, 2018 through July 18, 2018 and a \$20,000.00 fine.** This Offer in compromise is relative to the following alleged violations:

Incident of April 19, 2018

Sec. 30-86(b) of the Connecticut General Statutes
Sale of delivery of alcoholic liquor to minors


Sec. 30-6-A24 of the Regulations of Connecticut State Agencies
Conduct of permit premises

This Offer must be signed and returned with any payment due within twenty-one (21) days of the offer date shown above. Failure to comply will result in a hearing before the Liquor Control Commission. Make checks payable to **"Treasurer, State of Connecticut."** Return the signed offer and payment to:

This Offer is made in lieu of a formal administrative hearing. The Respondent waives any further procedural steps, the right to seek judicial review or otherwise challenge or contest the validity of this Offer and its acceptance by the Department of Consumer Protection, and the right to an adjudicative hearing.

The Respondent agrees to the destruction of any alcoholic liquor seized as evidence.

OFFER IN COMPROMISE ADDENDUM

The Respondent (Bn Washington Street LLC, d/b/a Johnny Utah's) agrees to reimburse the City of Norwalk, specifically the Norwalk Police Department, the amount of \$3,912.74 which represents the spent police resources for April 19, 2018- April 20, 2018.

Further, the Respondent agrees to reimburse Fairfield University for the use of the private bus service on April 20, 2018 and for university safety officer resources for April 20, 2018.


Further, the Respondent agrees that the premises will remain closed during the period of suspension, except that after 60 days suspension (or June 19, 2018) alterations to the premises may begin.

Further, the Respondent agrees that no new permit for the permit premises will be approved or issued during the period of suspension, and that the permittee, the backer entity, nor any member of the backer entity, nor any relative of the permittee or the backer entity will have any management duties or ownership interest in any new permit for the permit premises.
