Real Estate Broker Business Entity Instructions

This application is for a Corporation, Limited Liability Company, or Partnership to obtain a Connecticut broker license.

All Applicants Must:

- The individual holds a Connecticut real estate broker license, or the individual recently passed the CT real estate broker licensing examination **OR**
- The individual holds an active broker license in a reciprocal state issued by examination.
 (Note: Reciprocal applicants from OH, FL, IL, IN will be required to take the State Portion of the Connecticut Real Estate Licensing Examination)
- The business entity holds a broker's license in a reciprocal state and the designated broker is licensed by examination.

AND

- Register the entity with the Connecticut Secretary of the State (<u>www.business.ct.gov</u>) <u>and</u> attach a copy of one of the following: Partnership Agreement, Articles of Organization or Articles of Incorporation
- If licensed in another state, obtain a written certificate of license history/license verification directly from the licensing authority in every state in which you currently hold a real estate license.
- Except for a publicly traded corporation there must be one or more licensed broker(s) who own at least 51% of the legal entity. No salesperson may have a controlling interest in the legal entity.

\$1,270.00 Legal Entity License Fees (\$120.00 application fee, \$1,130.00 license fee, \$20.00 guaranty fund fee) &
\$120.00 Application Fee for the designated broker (not required if designee is currently licensed as a Connecticut individual broker or recently passed the Connecticut broker licensing examination)
All payments must be in the form of a check or money order made payable to, "Treasurer, State of Connecticut." Application fees are non-refundable.

Regarding Salespeople Who Wish to Affiliate with This Entity

- Connecticut licensed salespeople who wish to be affiliated with this legal entity must complete a Real Estate Salesperson Transfer Form. The \$25.00 transfer fee is required for each salesperson.
- Salespeople and brokers not licensed in Connecticut must apply for a Connecticut license if they will engage in the real estate business in Connecticut under the name of the business entity.
