In addition, the Board voted unanimously to refer this application and attached employer letter indicating unlicensed activity to DCP Trade Practices Division for investigation into alleged plumbing and heating/cooling work activity.

The Board voted unanimously to deny Mr. Ortiz-Pastor's (P-2) application due to lack of proof of on the job training hours as required.

The Board voted unanimously to deny Mr. Spano's (P-2) application due to lack of registered apprenticeship and related instruction. Board Member Chris Bowman abstained.

### 1. Residential sprinkler system licensing requirements

No new discussion took place. Chairperson Charles Appleby is in attendance at today's Connecticut Fire Sprinkler Coalition meeting and will report back to the Board next month.

# 2. Public Act 14-199, Substitute Senate Bill No. 235 - An Act Concerning Revisions to the Transportation Statutes.

#### **NEW BUSINESS :**

#### 1. Discussion on PSI testing

Frank DaCato expressed his concerns over the fact that the PSI allows applicants to take the 2003, 2006, 2009, and 2012 Code Books into the examination, however, Connecticut adheres to the 2003 Code when installing such plumbing work on site.

Director Richard M. Hurlburt stated that this practice stems from a lack of availability of the 2003 Code Book, and that the questions on the examination are formatted in such a way that any of these Code Book versions can be used. The test is based on minimum competency and general knowledge questions.

In addition, Director Hurlburt stated that the examination is designed to test entry-level persons. The codes and standards, on the average, change every three years. During the 4 to 5 year apprenticeship program taken by the majority of applicants they will see the change occur, and the instructors of such apprentices teach the apprentice <u>how to</u> <u>use the codes and standards</u>, which will be subject to change during the entire career in any licensed occupational area.

The PSI examination review of the P-1 and P-2 license types will take place in April of 2015 and all Board members are encouraged to attend.

## 2. New Commissioner Appointed

The Board requested that newly appointed Commissioner Jonathan Harris be invited to attend an upcoming meeting.

### DCP TRADE PRACTICES DIVISION COMPLAINT REPORT:

1. The Board reviewed a complaint report consisting of open cases submitted by the DCP Trade Practices Division dated 2/10/10 to 1/7/15, and a complaint report consisting of closed cases dated 2/10/10 to 1/7/15.

2. The Board inquired about the number of cases that they referred to Trade Practices for investigation in the year 2014. Frank DaCato and Karen Layman will confirm the number of cases and provide the Board with this information.

3. Richard Maloney, Director of Trade Practices, appeared before the Board. Melissa Sheffy inquired about legislation included in Public Act No. 14-210, in which the Department is required to provide an annual report consisting of complaints and other related information regarding such complaints. Richard Maloney confirmed that he is aware of this and is currently generating this report for 2014 complaints, which is due January 15, 2015.

4. Richard Maloney confirmed that he will be submitting a report of closed complaints for the entire year of 2014 for the next meeting, per the Board's request.

5. Richard Maloney provided a summary on the progress being made within the Trade Practices Division with regards to the enforcement of licensure laws, and stated that they are moving in a positive direction. Discussion took place on procedures for investigations and recent site visits.
