#### **CORRESPONDENCE**

1. Correspondence dated 12/3/07 from National Association of Power Engineers, requesting the Board to consider a specific license for boiler and chiller operators.

David Winchell appeared before the Board today on behalf of the Connecticut Chapter 11of the national Association of Power Engineers to discuss Public Act No. 07-183 (An act concerning licensure for Heating, Piping, and Cooling Work). Mr. Winchell informed the Board of a proposed Power Engineer license or a Plant Operator license to cover a Power Engineer or Plant Operator, who is an individual who operates and maintains the various utility systems of a stationary facility. This includes the operation and maintenance equipment such as boilers, steam turbines, high temperature hot water heating systems, cooling systems, turbo-generators, stationary diesels, gas turbines, and compressed gas systems. Licensing requirements will apply to all industrial, commercial, and institutional facilities located in the State of Connecticut.

Board member Cameron G. Champlin, Jr. informed Mr. Winchell that he would have to lobby the legislature during session concerning his proposed Power Engineer or Plant Operator license.

2. Correspondence from Naugatuck Valley Community College regarding Sheet Metal Apprenticeship Training.

## FORMAL ADMINISTRATIVE HEARINGS

In the Matter of Timothy Kennedy Docket No. 07-1106

This matter was the subject of a Formal Administrative Hearing held on 9/27/07 and the hearing was continued to the Board's 11/29/07 meeting. Mr. Kennedy was out of the country and unable to attend the Board's 11/29/07 and the hearing was continued to a "Special Meeting" on 1/10/08. The hearing was continued on 1/10/08 and Mr. Kennedy appeared Pro-Se, and the hearing was continued to the Board's 1/24/08 meeting. The Formal Administrative Hearing was continued on 1/24/08 and the hearing was concluded, and Mr. Kennedy was not present. After further discussion on this matter at the Board's 1/24/08 meeting, the Board voted to impose a Civil Penalty in the amount of \$32,000.00, Restitution in the amount of \$3,500.00, immediate revocation of Mr. Kennedy's (S-1) Unlimited Contractor license and refer the matter to the CT Attorney General for further enforcement. Board member Robert H. Barrieau was opposed.
