The Board reviewed this draft letter and agreed that it would be appropriate to send out this letter, along with relevant statutes and a shorthand reporter application, upon notification to DCP that there may be an unlicensed person offering shorthand reporter services.

2. Continuing Education Audit for Shorthand Reporters
