Docket Number 15-207 CVS #1149

Attorney Lynn Fiore presented this case. Commissioner Beaudin 'stepped down'. This case involved Drug Control investigated this pharmacy for failing to report a loss of controlled substances within 72 hours and for failing to have its first-time pharmacy manager appear before the Commission of Pharmacy. This agreement calls for payment of a civil penalty in the amount of \$2,000.

**Commission Action:** Commissioner Inguanti moved, seconded by Commissioner DeFazio and passed by a vote of 3-0 to accept and approve the aforementioned settlement agreement.

#### Docket Number 15-226 CVS #1213

Attorney Lynn Fiore presented this case. No Commissioner 'stepped down'. This case involved Drug Control investigated this pharmacy for failing to have its first-time pharmacy manager appear before the Commission of Pharmacy. This agreement calls for payment of a civil penalty in the amount of \$1,000

Attorney Lynn Fiore presented this case. No Commissioner 'stepped down'. This case involved that alleged this pharmacy permitted the disclosure of a customer's confidential pharmacy information. This settlement agreement resolves the matter by way of payment of a \$1000 civil penalty, the standard penalty for this type of violation.

Attorney Lynn Fiore presented this case. Commissioner Carbray 'stepped down'. This case involved this pharmacist committed a prescription error and failed to initiate the process to complete a Quality Assurance review. The agreement calls for a \$500 civil penalty and completion of the continuing education course related to prescription errors.
