## **Comments on Public Engagement Questions**

Comments are organized by, the numbers and letters in your survey questions.

### Focus Area: Increased Recycling - d. Education and Outreach

- 1. South Portland, Maine, in partnership with Eco-Maine, implemented a pilot program to reduce recycling contamination. It was a Community Based Social Marketing (CBSM) approach. After 8 weeks of very targeted education, "boots on the ground" using interns, they noted a significant reduction (5%) In contamination. Residents responded positively to the increased education through "oops tags" and conversations with the college interns, who were given a 1 week training program. COVID interrupted expansion of the program this past summer. They planned to reach out to multi family units next. They have created a Toolkit for the program which they are willing to share.
- 2. Barriers is cost for the "boots on the ground" outreach and education. Grants would be helpful to help towns
- 3. Implementing such a program would reduce environmental and economic costs associated with contaminated loads of recycling
- 4. Lucy Perkins is the Sustainability Coordinator for the City of Portland who presented this pilot in an aug 12th NRRC webinar along with Matt Grondin, Communications Coordinator for Eco Maine. Perhaps they would be willing to present.
- 5. DEEP, through Recycle CT could adopt and promote a similar toolkit for CT.

## **Focus Area: Organics**

Organics: a. Food Scrap Collection.

1. Two good examples: 1) The City of Cambridge implemented an organics diversion program (note pg. 8). Cambridge says "it costs less money to depose of food waste in the compost program than in the trash."
