After recently learning of Connecticut Water Company's decision to limit their Exclusive Service Area (ESA) claim to areas around their existing water systems in the Town's of Pomfret and Woodstock, Aquarion would like to amend Section 2. (1.) of it's "Exclusive Service Area Declaration Form Eastern Connecticut WUCC" which it submitted on November 8, 2016, to include ESA declarations for all of the Town of Pomfret and Woodstock other than those areas currently being served by other public water suppliers or being claimed by the Connecticut Water Company. Aquarion would plan to served any new community water systems in the Towns of Pomfret or Woodstock as satellite water systems.

Aquarion's withdrawal of ESA claims to DEEP Lands in the Eastern WUCC Region where Aquarion has made ESA claims as stated in it's letter to you dated January 6, 2017, would also apply to the Towns of Pomfret and Woodstock.

Aquarion Water Company is the public water provider for approximately 195,600 customer accounts and more than 632,400 people in 51 cities and towns throughout Connecticut. Aquarion is familiar with local, regional and state land use plans, local zoning regulations and recent growth trends in our proposed exclusive service area. Aquarion provides water service locally in the towns of Mansfield and Lebanon.

2. Identify the person or group at your utility or municipality responsible for reviewing and/or enforcing such plans and regulations, and what other groups serve to advise your utility or municipality on changes in land use and new developments at the local level.

At Aquarion the Engineering and Planning Department is responsible for reviewing plans and regulations. Municipal Planning and Zoning Departments and regional COGs advise us of changes in land use and development at the local level.

3. Do the current zoning, land use plans, and growth trends in the municipalities in your proposed exclusive service area currently suggest that new public water systems, or an extension of public water systems, will be needed?

In some municipalities Yes, current growth trends suggest that new public water systems may be needed, while in other municipalities current growth trends do not indicate the need for new public water systems.

Aquarion has extensive experience with system hydraulics, including managing elevation changes and pressure zones. Aquarion Water Company's water systems have a total of 193 separate pressure zones.

1. Please describe your current source water protection program for protecting current and future sources of supply.

Aquarion actively protects its surface and groundwater supplies through a comprehensive source protection program administered by Aquarion's Watershed and Environmental Management (WEM) Department. Elements of the source protection plan include regular watershed sanitary inspections, regular monitoring of source area activities and conditions, review of proposed land use and development changes with local regulatory agencies, emergency spill response procedures, and coordination with state and local authorities for remediation activities. Aquarion also performs regular patrol and maintenance of Aquarion watershed properties through full and part-time security patrol officers. Aquarion's WEM Department monitors water quality continually and field technicians often support source protection initiatives.

2. If you will serve any or all of your proposed exclusive service area via satellite systems, do you have experience owning and operating such systems? Please describe.

Yes, Aquarion has extensive experience operating satellite systems. Aquarion owns and operates over 50 satellite systems throughout Connecticut.

3. Please describe your technical capacity to operate a public water system. Will you own and operate new systems, or do you expect to own new systems and retain a contract operator to perform the day to day tasks?

Aquarion Water Company has 290 employees in Connecticut and has been in the public water supply business since 1857. We would expect to own and operate new systems. We have the proven technical capacity to operate water systems.

4. Please describe your managerial capacity to operate a public water system. What hierarchy is in place to make decisions? How quickly can/will decisions be able to be made during an emergency? Describe your experience with long term planning of infrastructure assets.

Aquarion Water Company has the employees and managerial capacity to operate public water systems. Aquarion has Supply Operations, Utility Operations, Engineering and Planning and Water Quality Department's with Directors that can quickly make decisions during emergency events. The Engineering and Planning Department has multiple employees with experience in long term planning of infrastructure assets. Aquarion also has multiple engineering consultants that are used for the long term planning of infrastructure assets.

5. Please describe your financial capacity to operate a public water system. Is capital funding for emergency repairs available? Is there a capital improvement budget available for long term asset replacement? What types of financial resources can be utilized to maintain a system? Is there financing available to retain consultants and contractors to design and implement repairs?

Aquarion Water Company has ample financial resources to operate public water systems. Capital funding for emergency repairs is available. Aquarion has a substantial capital budget for long term asset replacement. Water systems are maintained with financial resources from the short term capital budget or expense budget depending on the situation. Financial resources are available to retain consultants and contractors to design and implement repairs.

6. If you currently provide public water service, please describe the number and types of complaints received by your utility for the past three years.

Aquarion receives water quality complaints from customers regarding the appearance or taste and odor of the water. Aquarion has a Product Quality Team that meets monthly to review water quality complaints to try to determine their cause and look at what potential actions can be taken to minimize water quality complaints.

7. If you will serve any or all of your proposed exclusive service area via an extension of your existing service area, please describe any water quality or reporting violations incurred over the past two years.

Aquarion would propose to use its Eastern Division rates. The estimated annual cost for a family of four using 109,500 gallons of water per year would be \$774.45.


