Gov. Ned Lamont's emergency powers extended through September

The General Assembly voted for a 44-word resolution extending Gov. Ned Lamont's emergency powers through Sept. 30, making Connecticut among the last in the northeast under a COVID-19 state of emergency.

- Executive Orders
 - Executive Order No. 13E (09/03/2021)
 - -Establishment of temporary nurse aide program.
 - Executive Order No. 13F (09/03/2021)
 - -Modification of deadline for long-term care facility staff to receive vaccinations.
 - Executive Order No. 13G (09/10/2021)
 - Replaces and clarifies Executive Order No. 13D on COVID-19 vaccination requirements for state employees, school employees, and childcare facility staff.
 - Executive Order No. 14 (09/28/2021)
 - -Extends the duration of nine previously issued executive orders to February 15, 2022; Extends the duration of agency or municipal orders that were issued pursuant to any unexpired COVID-19 order; and Repeals, renews, and revises Executive Order No. 11D Sections 2 and 3 concerning the emergency procurement of essential goods and services.
 - Executive Order No. 14A (09/30/2021)
 - Revised version of Executive Order No. 14.
- Updated Guidance sent on 09/27/2021 for the Operation of Interscholastic, Youth and other Amateur Sport Activities during the COVID-19 Pandemic
- COVID-19 vaccine eligibility:
 - All individuals who are 12 years of age or older and live, work, or attend school in Connecticut are eligible to receive the COVID-19 vaccine.

COVID-19 Suspension of Certification Renewal:

Due to the COVID-19 pandemic Governor Lamont on 3/10/20 issued a <u>Declaration of Public Health and Civil Preparedness Emergencies</u> (Declaration).

As a result of the CT DPH Commissioner's 3/30/20 order, water operator renewal requirements are suspended ("Suspended Renewal") for those certifications due to expire during the Declaration.

Operators, with a Suspended Renewal should note the following:

- CT DPH has extended out expiration dates to keep certifications active,
- While the period for renewal has have been extended your next period will be shortened by an equivalent amount,
- This means that operators will have less time to accumulate the require training contact hours in their next renewal cycle,
- It is therefore advantageous to renew sooner than later, **Operator should begin to prepare for the reinstatement of renewal requirements**,
- Operators don't have to wait to the end of the Declaration to renew their certification,
- Operators may request their renewal application via email send email request to dph.opcert@ct.gov
 (please provide your name and certification number),
- Note the following link to the <u>Approved Training Internet</u>, <u>Online and Correspondence Courses</u>,
- View the status of their certification and expiration date, <u>without password</u>, on the <u>eLicense</u> website (click on "Online Services", click on "Lookup a License", enter in First Name and Last Name, click "Submit").
















1-Year Percent of Normal Precipitation

DWSRF Update

- Public hearing on DWSRF Draft Intended Use Plan (IUP) for SFY 2022 was held on August 18 and DPH is currently preparing the Hearing Report
- The Infrastructure Investment and Jobs Act (IIJA) passed through the Senate and is currently with the House of Representatives for a vote to be held sometime in October. Current <u>national</u> DWSRF provisions include:
 - \$11.7 billion over the next 5 years for any eligible project
 - \$15 billion for lead service line replacements
 - \$4 billion for emerging contaminants with a focus of PFAS/PFOA
 - Reauthorization annual appropriations for the DWSRF at levels between \$2.4 \$3.25 billion annually from 2022 2025 (4 years)

Drinking Water Needs Survey and Assessment (DWINSA)

The DWINSA determines:

- 20-year capital need for drinking water infrastructure investment (nationally & for CT)
- Results determine Connecticut's DWSRF funding amount
- More documented need = more \$\$\$ in the DWSRF which would increase funding for loans, subsidy, funding that support staff providing technical assistance to pws' & certified operators, contracts for technical assistance providers etc.
- 23 PWS' are included in the current DWINSA
- Coming to a close December 10, 2021


