#### SCHOOL ISSUES

Ponce Health Sciences University. Ponce, Puerto Rico

The Department of Public Health was contacted by Ponce Health Sciences University School of Nursing, located in Ponce, Puerto Rico, to discuss if a pre-licensure Bachelor of Science in Nursing graduate would be declared eligible to sit for the CT NCLEX-RN without engaging in the Commission of Graduate of Foreign Nursing School (CGFNS) process. The Department informed Ponce Health Sciences University School of Nursing that graduates from that program would not be considered foreign trained and would not need to complete the CG NFS process to be authorized to sit for the NCLEX exam.

## NCLEX Examination Scores

Helen Smith, Nurse Consultant, DPH reported Registered Nurse and License Practical Nurse NCLEX Examination scores for May 1, 2016 through April 30, 2017. Schools which did not have an 80% pass rate will be invited to a Board meeting to discuss their results.

Mary Brown moved, and Gina Reiners seconded, to remove Gateway Community College from conditional approval because they now have a 93% pass rate. The motion passed unanimously/

Mary Brown moved, and Gina Reiners seconded, to remove the University of St. Joseph Accelerated Program from conditional approval because they now have a 96% pass rate. The motion passed with all in favor except Gina Reiners who abstained.

# **REINSTATMENT REQUEST**

Concetta Mancini, RN - Petition No. 2015-1518

Kathleen Boulware, Public Health Services Manager, DPH presented a reinstatement request for Concetta Mancini. Ms. Mancini's license was placed on probation subsequent to a July 18, 2012 Consent Order. Ms. Mancini's license lapsed on September 30, 2013 prior to the completion of probation.

It was the consensus of the Board to recommend license reinstatement pursuant to a Reinstatement Consent Order which imposes a four year probation with the usual conditions.

## MOTION FOR SUMMARY SUSPENSION

Gina Reiners moved to grant the Department's Motion for Summary Suspension in that respondent's continued practice as a nurse is a clear and immediate danger to public health, safety and welfare. The motion was seconded by Mary Dietmann and passed unanimously.

Chair Bouffard signed the Summary Suspension Order. A hearing is scheduled for June 21, 2017.

## PRE-HEARING REVIEW

Mary Howe, RN - Petition No. 2015-370

Staff Attorney Joelle Newton presented the Board with a pre-hearing review packet in the matter of Mary Howe, RN. Ms. Howe was present with Attorney Richard Brown.

Following a review of the exhibits the Board Mary Brown made a recommendation for probation for a period of six months to one year with monthly employer reports and completion of course work relating to the assessment and care of patients with a head trauma and stroke patients. Following additional discussion, it was recommended that this matter be scheduled for a hearing in that the information currently presented is not sufficient for the Board to make an informed decision.

Amanda Espinosa, LPN - Petition No. 2017-206

Staff Attorney Joelle Newton presented the Board with a Consent Order for Amanda Espinosa. Ms. Espinosa was not present or represented by counsel. Mary Brown moved and Gina Reiners seconded, to approve the Consent Order.

The motion passed unanimously. Chair Bouffard signed the Order which imposes a probation for a period of one year.
