# **NATIONAL COUNCIL STATE BOARDS OF NURSING**

Chair Bouffard and Kathleen Boulware provided an overview of the National Council State Boards of Nursing midyear meeting which was held in Salt Lake City on March 13-15, 2017. Geraldine Marrocco reported on the APRN Roundtable that was held on April 4, 2017.

# **SCHOOL ISSUES**

Stone Academy – Request to approve Kate Galambos R.N., as interim LPN Program Manager Holly Mulrenan, and Kate Galambos were present from Stone Academy.

Gina Reiners made a motion, seconded by Geraldine Marrocco, to approve Ms. Galambos as the Interim LPN Program Manager at the Stone Academy West Haven campus. The motion passed unanimously.

Helen Smith, Nurse Consultant, DPH reported on the following:

- St. Vincent's College updated the Department, on 03/27/2017, that the College has recently engaged in a significant dialogue with Sacred Heart University to pursue the potential acquisition of St. Vincent's College. Currently the two institutions have entered into a management agreement which merges valuable resources and is mutually beneficial. There will be no change in faculty, location curriculum or clinical affiliations.
- Porter & Chester Institute informed the Department that they may need to add an additional classroom in the future (Waterbury campus). The Department would not make an on-site visit (as visits to the Waterbury campus were made in the fall of 2016 and in 02/2017 -prior to a 2nd nursing laboratory being "opened"). Patti Donovan, the Director of Practical Nursing and Curriculum Chair will keep the Department informed.

Ms. Smith and Sara Montauti, Health Program Assistant 2, DPH discussed the 2016 RN and LPN Program statistics. DPH staff will review attrition rates for select RN programs to determine if Board review will be necessary.
