2. \$217,412.00. The additional funds are to allow Contractor to continue services for an additional 9 months.
3. The budget on page 2 of Amendment #1 shall be deleted and replaced in its entirety with the budget of page 2 of this amendment.
4. The term of this contract shall be extended by 9 months and the end date of the contract is changed from 9/30/16 to 6/30/17.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.





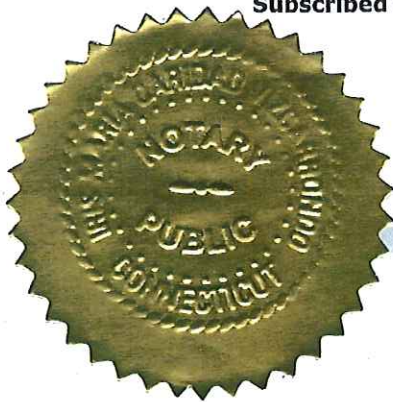
