ASD Waiver Update by Amy Dumont and Kathy Bruni:

- The Autism Lifespan Waiver was renewed beginning 1/1/2018 for 5 years
- 106 individuals currently being served and working towards 114 by end of 2019
- Waiver is expected to expand by 10 slots per year over the next 5 years
- 13 individuals placed onto the waiver in 2018
- 3 individuals came off the waiver in 2018
- 1502 individuals on the Waitlist as of 6/12/2019
- Average cost per individual: \$23,219
- 51 Providers enrolled
- Average caseload for the DSS Case Managers: 35
