- 9/7/2021 it was sent back
- Once released, it will be released and posted for 7 weeks
- Going in the right direction

ASD Waiver Update by Amy Dumont:

- 1912 individuals on the autism waitlist
- 124 clients currently receiving services
- DSS Resource Specialists, Cathy Calway and Nathaniel Calway have many Resource Presentations and events lined up with school systems. Cathy Calway shared with Council
- Amy provided timeline overview of the RFP process. On 7/28/21 Bill sent RFP, Request for Application to Amy for review. Was sent to contract department in August. 8/31/21 sent back to Contract Department on 8/31. Contract department replied with questions. Sent back to Contract department on 9/7/21. Once released, it is released for 7 weeks
- Roles of DSS Staff were discussed
- Staffing issues were discussed including Case Manager Supervisor position has not been filled as well as additional Case Manager positions will be needed once more funding for slots are approved.
- Bill Halsey has taken on Kate's roll as interim Director
- Beacon questions/concerns will continue to go to Bill Halsey at this time
- Housing Committee will continue to report to Bill Halsey
- Provider issues will go to Lisa Bonetti and will forward to appropriate staff
- Provider agency applications is a multi-step process. Applications go to Lisa Bonetti which are forwarded to Amy Dumont for approval. At this point application process

is referred to QA and then to Gainwell for billing and payment process. Debbie Hockla-Kaba is our relations contact person at Gainwell.

Individual Providers are credentialed through Beacon Health Options.

Other Business:

- It was decided to start a Marketing workgroup to have discussions on what the DSS Autism Lifespan Waiver and services through Beacon Health Options both have to offer. Lisa will send out email regarding council members who would like to join.
- Lynn Ricci discussed journal article
- Bryan Klimkiewicz is still willing and able to set up a meeting/structure to receive input regarding federal dollars geared to Recovery
- Housing Committee update Amy James discussed that there has not been much movement. No funding for wrap-around services. Individuals are unable to choose who they would like to live with which is an issue. DSS Autism Lifespan Waiver does not have funding for housing services.
- Melissa Kremmel, Executive Director for CT Family Support Network discussed Housing Roommate matches. Planning on holding a live event
- Discussion of continuing Housing Committee as it was successful. Amy will reach out to Bill Halsey to see if he will continue as the head of this group.
- Provider rate increases were discussed
