- Autism staff is reviewing individuals on the waitlist for 50 individuals to come off the waitlist. Financial eligibility for Medicaid is a big factor.
- Prioritizing waitlist was suggested. Waitlist is by application date as it's unfair to determine one individual's needs over another.
- Lois suggested setting up a committee to research prioritizing waitlist
- Representative Abercrombie suggested waiting for the next waiver renewal for making any changes as this should not be rushed.
