- 13 individuals either declined services or moved out of state
- 2007 individuals on the waitlist
- Lauren Figuenick new Case Manager began last week, came over from DCF
- Terrance Moore, new Case Manager coming over from DCF, will begin next week
- Five new providers have been added to our list
- 91 Providers are currently enrolled
- Training expense resolution is still being discussed
- Paul Chase assists with the financial eligibility
- Technical Assistance Contract reviews other states to see what may meet the needs in CT

# **Center of Excellence Update**:

• Virtual Platform

- Jennifer Cavallaro is working on updating language for request for proposal and qualification
- Goal is to have it posted for February 13<sup>th</sup>
- Monies dedicated for ASDAC \$500,000 allocated per year from General Funds. \$650,000 has been rolled over
- Yana suggested Self-Advocates for Providers to represent
