The Fixed Margin Price is based on the daily Oil Price Information Service (OPIS) New Haven rack average price for low sulfur red dye distillate heating oil, plus a fixed margin of 35 cents per gallon.

This year's Fixed Margin Pricing Program includes county differentials in the pricing mechanism. The differentials vary from county to county. The price of oil including the fixed margin and the county differentials are as follows:
