Question: Susan Yurasevecz - Are you able to share your shapefiles on the school mapping so that I might be able to use that. I also have access to graph data. And I'm curious about different types of injuries around those school locations.

Answer: Kristen Levesque- Yes, the mapping data that shows the vicinity of schools, and the buffer zones. We're working to develop a story map as well that will help to have even more comprehensive information.

Question: Joh Slifka - I'm curious, with the accessibility piece in the groups and organizations that you're working on. Who is bringing the perspective from the disability community to your meetings and to your sessions into your work. **Answer:** Kristen Levesque - So far, we've partnered with some of the school districts, and have done some outreach with the administration at the school to get some more information. Our pedestrian and bicycle safety education working group is in its infancy just really starting so we would welcome some members to be able to help us with some of the different accessibility concerns.

Comment: Garrett Eucalitto: John, it would be great if you can provide Kristin with the contacts you think are best to loop into these working groups. Thank you.

Comment: Eileen McMurrer - I so appreciate that you've highlighted children as being a vulnerable population when using the roads. And so, as I hear you describe this magnificent work that's going on with safe routes to school, I immediately think about the safe route to childcare, because little people grow up into bigger people. If there are ways that the office of early childhood could support some of this work in terms of getting information out to parents at the earliest opportunity, I would be glad to participate in that.
