Connecticut's Beach Tier Classification Guide

<u>Classification</u>	<u>Definition</u>	Notes
Tier I	Meets the minimum recommended sampling requirements and frequency and No more than one closure occurance during previous bathing season.	Sampled weekly; and 0 or 1 closure event/season
Tier II	Meets the minimum recommended sampling requirements and frequency and No more than three closure occurances during the bathing season.	Sampled weekly; and 2 or 3 closure events/season
Tier III	Does not meet minimum recommended sampling requirements and frequency or <u>more than three closures</u> occurances during the bathing season or <u>beaches not monitored</u> .	Not sampled weekly; or more than 3 closure events/season
