Electronic Visit Verification – It's Here! – How Does it Work and How Will It Benefit Me and My PCA? LIVE Demonstration – Kathy Bruni, Department of Social Services and Lori Grice, DXC Technology - The State is officially implementing Electronic Visit Verification (EVV) in 2019. Learn what EVV is, when you may need to make the transition and how you can use it to eliminate paper timesheets and faxing and reduce payroll errors and delays. This presentation will include a live demonstration of the EVV timekeeping system and an account of user experience.

I Have to Do What? Your responsibilities as An Employer or Employer of Record

Being an employer comes with a lot of flexibility regarding who, when, where and how your services are provided but it also means taking on a lot of responsibility. This panel discussion will provide an overview of the key responsibilities of Employers and/or Employers of Record so that you are armed with the information and resources you need to be successful.

What Are Able Accounts and Are They Right for Me? – Speaker from Office of the State Treasurer - TBD - The federal Achieving a Better Life Experience (ABLE) Act became federal law in 2014. It gives individuals with disabilities the opportunity to establish tax-deferred savings accounts to maintain their independence. In 2015 the State Legislature passed a law to implement the ABLE Act in Connecticut. Learn what ABLE Accounts are, how they work and if they may be an option for you.
