III. CSDE Updates

a. Staffing:

Dr. Melissa K. Wlodarczyk Hickey gave a review to the Council on the job openings that haven been posted for the Center for Literacy Research and Reading Success, Academic Office – 5 Associate Consultants and 1 Administrative Assistant. She also introduced the new Bureau Chief of the Office of Dyslexia and Reading Disabilities, Talent Office, Dr. Jule McCombes-Tolis. Dr. McCombes-Tollis gave a staff update for the Office of Dyslexia and Reading Disabilities and Informed the Council on the work and responsibilities of the new Office of Dyslexia and Reading Disabilities. b. Literacy Professional Learning and Supports:

Dr. Melissa K. Wlodarczyk Hickey gave an overview to the Council on the CSDE professional learning and supports for literacy including: Connecticut's Literacy Model Strategy with University of Connecticut, Hill for Literacy, and Literacy How; ReadConn with Public Consulting Group (PCG); Region 2 Comprehensive Center (WestEd) Networked Improvement Community; and the Science of Reading Masterclass with Connecticut Association of Public School Superintendents. Dr. Melissa K. Wlodarczyk Hickey referred to Council member Frances Rabinowitz to further discuss the Science of Reading Masterclass with Connecticut Association of Public School. Council member Frances Rabinowitz extended an invitation to the Council to join the upcoming February 8, 2023, Science of Reading Masterclass plenary session. The Council was given an opportunity to ask questions and provide input.

c. Reading Curriculum Models and Programs:

Dr. Melissa K. Wlodarczyk Hickey provided the Council with the dedicated webpage for Connecticut Approved K-3 Reading Curriculum Models or Programs and a link to the 2022 Application Requesting a Waiver of Connecticut Approved K-3 Reading Curriculum Models and Programs. d. Higher Education Collaborations:

Dr. Melissa K. Wlodarczyk Hickey reported on the current progress with the higher education and Literacy Research & Reading Success Center (Center) collaborations. On October 14, 2022, she had a dean's meeting where they scheduled another meeting for January 26, 2023, higher education literacy group meeting. There will be over 30 higher education institutions participating in the January meeting to discuss literacy, not limited to how literacy is taught in pre-service teacher education programs and legislation to strength support for pre-service teacher education programs.
