The Council's facilitator Dr. Melissa K. Wlodarczyk Hickey, Director of Literacy Research & Reading Success, State of Connecticut Department of Education (CSDE), convened the meeting at 1:03 p.m. and the Council's Clerk called attendance. Dr. Melissa K. Wlodarczyk Hickey welcomed the Council and reviewed the Council norms.

III. Explore Our Connecticut Student Literacy Data

Ajit Gopalakrishnan, Chief Performance Officer, Connecticut State Department of Education shared information regarding Connecticut student literacy data. Mr. Gopalakrishnan noted that prior to the COVID pandemic, around 54 percent of Connecticut students were proficient in English language arts (ELA) on the Smarter Balanced assessment, and after the COVID pandemic the proficiency rate declined to 47 percent, nearly 19,000 Connecticut students are not proficient in ELA in Grade 3. The pattern existed prior to covid but was exacerbated. He also shared that the majority of Connecticut students below proficiency in Grade 3 remain below in Grade 6 ELA.
