SUBJECT: ED 236 Immigrant Students and Youth Program Survey

In order for the State of Connecticut to qualify for federal funding for supplementary programs for Immigrant Students and Youth as authorized by 20 USC 6801 et seq., as amended by P.L. 107-110, Sec. 3001, the state must annually determine the number of all immigrant students enrolled in public and nonpublic schools, Grades PK-12. Therefore, the U.S. Department of Education has directed the Connecticut State Department of Education (CSDE) to send out a survey to all districts, *regardless of the number of eligible children*, to <u>record the national origin of each immigrant child identified</u> in your school district as of October 1, 2016.

When completing the survey, please refer to the section which describes criteria for identifying and classifying immigrant children. <u>Please note that it is a child's immigration status, not</u> ethnicity or language dominance, which determines his/her eligibility for assistance.

Federal regulations require that you collect this information from each public and nonpublic school in your district. The district must then collate the information on one composite survey to be submitted to the CSDE. Districts must keep records of each school's survey and the composite survey for auditing purposes. Only the composite ED 236 Immigrant Students and Youth Program Survey must be submitted to the CSDE on or before Friday, November 25, 2016.

Note that the ED 236 is now an electronic form on the CSDE secure Web site - https://www.csde.state.ct.us/. All submissions are now electronic.
