

Your Help Needed: Gathering Input on Promising Practices During the Pandemic

During the COVID-19 pandemic, Connecticut schools and colleges leveraged digital tools and approaches to support the continuation of learning, despite the need to adopt social distancing norms. While the return to in-person learning has eliminated the need for many of these practices, some have proven successful.

The Connecticut State Commission for Educational Technology seeks input on promising practices to guide future ed tech in our state. What uses of technology helped engage students in remote learning? What tools or approaches helped maintain strong connections between schools and colleges and parents and caretakers? What creative uses of technology helped tailor learning to students' personal needs and offer a supportive environment where they could thrive? How did the use of technology provide timely supports for teachers, instructors, and administrators? What changes took place with the help of digital tools that serve as models for streamlining the operation of schools and colleges?

The Commission welcomes broad input from the education community on these questions through a simple prompt that individuals may respond to using the ThoughtExchange platform:

What about technology use during the pandemic is worth keeping as we return to in-person education?

To that end, please share the letter below with your students, teachers, instructors, leaders, parents, and others who are invested in the education of Connecticut students. The platform is monitored continuously, and any thoughts containing inappropriate, hurtful, or personally identifying language will be immediately flagged and blocked from circulation. We will gather feedback from Thursday, July 8 through **Friday, August 13** and plan to publish a report of the most frequent and popular suggestions.
