Catherine comments on how her staff is planning on moving forward with this piece of learning. Bryan mentions ESY and considerations to be made.
- Tammy asked Jen if CPAC has noticed trends in parent concerns. Jen shared that families, including those on CPAC's two Parent Leaders Roundtables, continue to bring up the issue of the lack of appropriate interpretation and translation services for PPTs, and IEPs and the impact it has on monolingual families who are trying to effectively advocate for their child.
- Bryan makes suggestions to Tammy for the May 12 agenda. She asks Sean for agenda to the May 28 Dispute Resolution Ad-Hoc Committee meeting so that she can review with full Council.
