Membership Committee and Missy have noted that there is not enough members present today to make any decisions or votes. Bryan talks about diversity, representativeness of CT, demographics and says that Jon Copenhaver would be a great source to have cover this information. He adds for the Committee to keep CPAC in mind as a Parent Advocacy and thinks that they are well prepared to recommend parents to apply for a seat on the Council, (Bryan mentioned a second group), as well as the Black and Puerto Rican Caucus.
