I. FFY 2022 IDEA Part B Grant Presentation (Tom Boudreau) (1:30 pm.)

Tom Boudreau reviews the purpose of the IDEA Part B Grant. Also, reviews the PowerPoint that was emailed to the Council on the preliminary application, process and procedures. Asks the Council for questions. Bryan K. joins the meeting and adds to the discussion. Tom answers Lena Esposito's question to clarify who determines the qualifying criteria.

 - a. Agency/Parent Updates

Jane Hampton Smith (CPAC) A lot of expulsion and suspension with a zero tolerance lense and that is unusual. DCF referrals and threats at a higher rate. Students not receiving all services. Some students in general ed now and increased behavioral issues. Lots of bullying complaints. Talks shortage areas and parent was informed by administrators to homeschool due to issues with district. Jennifer L. adds regarding the parent concerns that she is receiving.

Nachi Bhatt (DCF) With students with disabilities, new administration to oversee juvenile special education and reintegration back into their communities.

Tom Cosker (Disability Rights CT) Hearing issues with remote learning and similar issues to CPAC's concern with students being referred to home school because districts are confused. Also mentions outplacements and programs.

Allison Kopie (BRS) Taking applications and they are early in the process. Running a training for vendors for customized employment and working with DDS.

Catherine Summ (BESBE-BRS) Planning and implementing for in person student activities. Often for parents only but due to request will be with students as well. Activities in the works for Spring with a focus on curriculum and fall in person planning.

Brian Smith (DDS) About to deal with the impact of retirements and creating internal system issues with case manager assignments for transition. They are working with retirees until positions filled. DDS resumed operating residential at 50 % capacity in February. In addition, mentions changes in leadership positions due to retirement.

Mia Giantonio (Student) Pleased about not having to wear a mask.

Michael Scanlon (Individual) Added comment and resource to the meeting chat:

Shared resources and links in regard to mental health, youth engagement, etc. Has a YouTube link to a presentation he did that covers a broad scope of mental health, youth engagement, employment and would like to share along with a pdf. In addition, the following are a link to the CPAC student and young adult page.
