### Notice of Intent to Adopt Regulations

The Commissioner of Energy and Environmental Protection, pursuant to Sections 4-168, 22a-6, and 23-4 of the Connecticut General Statutes, hereby gives notice of their intention to revise section 23-4-1 of the Regulations of Connecticut State Agencies.

The proposed regulation enumerates the state parks and recreation areas that have prohibited alcohol since prior to October 1, 1999 and that still prohibit alcohol, pursuant to section 23-4 of the Connecticut General Statutes. The proposal also expands on this list by including the areas that have been added in recent years pursuant to the regulatory authority of the Commissioner under RCSA 23-4-1 (e)(2)(D), and makes changes to restrictions on volume and sales.

The Department has prepared a fiscal note and a small business impact analysis that are available online and upon request for review.
