## - PRESS RELEASE -IMPORTANT PRIMARY DEADLINES APPROACHING

**HARTFORD:** Connecticut Secretary of the State Denise W. Merrill is alerting voters that important deadlines for the August 9 primaries are fast approaching.

The deadline for new or unaffiliated voters to register in person with the local registrar of voters or town clerk of the town of residence is **noon on August 8**.

The deadline for new or unaffiliated voters to register for the primary **by mail or online is August 4**. The mail-in application of new or unaffiliated voters must be received by the town registrar—or a voter registration agency or the Department of Motor Vehicles—by **August 4**.

Secretary Merrill said, "Local elections are arguably when the voters have the greatest impact. If there is a primary in your town, please don't miss the opportunity to choose who will represent your party on the ballot in November."

On August 9, polls will be open for registered Democrats and Republicans from 6:00 a.m. to 8:00 p.m. Voters can visit myvote.ct.gov to learn how to register, check their registration, find their polling locations and download absentee ballot applications.
