Department of Environmental Science and Forestry

The Department of Environmental Science and Forestry anticipates having a Summer Research Assistant position available in 2024 to assist with microbial ecology and molecular biology research. This is an excellent opportunity to gain professional experience and learn new skills. The position is based in New Haven.

The position will involve work in molecular genetics, classical microbiology, and basic bioinformatics. Previous experience with microbiology techniques is preferred but not required. The position may involve local fieldwork and transportation will be provided, but the applicant should be prepared with gear for outdoor fieldwork.

The seasonal position will start at the end of May or early June depending on the applicant's availability and may extend through September 25, 2024, depending on project and funding. The regular hours are 8:30 a.m.-4:30 p.m., Monday through Friday, with a salary of \$16.00/hour.
