Subject: Notification of Legislative Changes for Assault Weapons

Effective immediately, no sales should be made of the following specified semiautomatic centerfire rifles, or copies or duplicates thereof with the capability of any such rifles, that were in production prior to or on the effective date of this legislation. We will also post a link to the legislative site for complete text of the statute.

Criteria for any weapon which is not on the list to categorize it as an assault weapon:

Any semiautomatic firearm regardless of whether such firearm is listed in subparagraphs (A) to (D), inclusive, of this subdivision, and regardless of the date such firearm was produced, that meets the following criteria:
A semiautomatic, centerfire rifle that has an ability to accept a detachable magazine and has at least one of the following:
Folding or telescoping stock
Any grip of the weapon including a thumbhole stock or any other stock, the use of which would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing
Forward pistol grip
Flash suppressor
Grenade launcher
flare launcher
fixed magazine that accepts more than 10 rounds
overall length of less than thirty inches
a semiautomatic, centerfire rifle that has a fixed magazine with the ability to accept more than ten rounds

a semiautomatic, centerfire rifle that has an overall length of less than thirty inches		
a semiautomatic pistol that has an ability to accept a detachable magazine and has at least one of the following:	an ability to accept a detachable ammunition magazine that attaches at some location outside of the pistol grip	a threaded barrel capable of accepting a flash suppressor, forward pistol grip or silencer
a shroud that is attached to or partially or completely encircles, the barrel and that permits the shooter to fire the firearm without being burned, except a slide that encloses the barrel		
a second hand grip		
a semiautomatic pistol with a fixed magazine that has the ability to accept more than ten rounds		
a semiautomatic shotgun that has both of the following:	a folding or telescoping stock	Any grip of the weapon including a thumbhole stock or any other stock, the use of which would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing
a semiautomatic shotgun that has the ability to accept a detachable magazine		
a shotgun with a revolving cylinder or;		
A part or combination of parts designed or intended to convert a firearm into an assault weapon, as defined in any provision of subparagraphs (B) to (E), inclusive, of this subdivision, or any combination of parts from which an assault weapon, as defined in any provision of subparagraphs (b) to (e), inclusive, of this subdivision, may be assembled if those parts are in the possession or under the control of the same person.		

Certificates of Possession must be applied for prior to January 1, 2014. Applications are available on the web at ct.gov/despp. Once the menu appears on the left hand side, click on State Police and then Special Licensing and Firearms Unit and then the Firearms link. There will also be a link for the transfer of an assault weapon to a dealer. As always you can obtain these through our office as well.
