PA 16-217 PREPAREDNESS ORGANIZATIONS.
This bill shall take effect October 1, 2016.

As of this date, the Governor has signed two hundred thirty one (231) bills and vetoed eight (8) bills of the 2016 Legislative Session. The Governor has signed four (4) bills and has exercised line item veto authority on PA 16-2 of the 2016 May Special Session.
