Governor Dannel P. Malloy signed the following legislation of the 2018 Regular Session on May 29:

SB 295 PA 18-48	AN ACT CONCERNING THE LEGISLATIVE COMMISSIONERS' RECOMMENDATIONS REGARDING TECHNICAL REVISIONS TO THE PUBLIC HEALTH STATUTES. This bill is effective from passage.
HB 5252 PA 18-22	AN ACT CONCERNING REVISIONS TO THE CONNECTICUT ANTITRUST ACT AND DISCOVERY CONDUCTED BY THE ATTORNEY GENERAL IN WHISTLE-BLOWER AND FALSE CLAIMS ACTIONS This bill takes effect October 1, 2018.
HB 5442 PA 18-27	AN ACT CONCERNING THE PARTICIPATION OF NONPROFIT ENTITIES IN WORKER COOPERATIVES. This bill takes effect October 1, 2018
HB 5579 PA 18-30	AN ACT CONCERNING COSTS FOR IGNITION INTERLOCK DEVICE SERVICES FOR PERSONS WHO ARE INDIGENT AND ARE SEEKING RESTORATION OF A MOTOR VEHICLE OPERATOR'S LICENSE. This bill takes effect October 1, 2018.
HB 5515 PA 18-28	AN ACT CONCERNING THE AUTHORITY OF A ZONING COMMISSION TO REGULATE THE BRIGHTNESS AND ILLUMINATION OF ADVERTISING SIGNS AND BILLBOARDS. This bill takes effect July 1, 2018.
SB 170 PA 18-39	AN ACT CONCERNING THE DEPARTMENT OF MENTAL HEALTH AND ADDICTION SERVICES' RECOMMENDATIONS REGARDING STREAMLINING REPORTS This bill takes effect July 1, 2018.
SB 186 PA 18-15	AN ACT CONCERNING SCHOOL COUNSELORS This bill takes effect July 1, 2018.

SB 195 PA 18-16	AN ACT CONCERNING CHANGES TO PHARMACY AND DRUG CONTROL STATUTES. This bill takes effect January 1, 2019.
SB 333 PA 18-18	AN ACT CONCERNING MUNICIPAL ELECTRIC UTILITIES AND RATE DESIGN STUDIES. This bill is effective from passage.
HB 5507 SA 18-4	AN ACT CONCERNING THE SOUTH CENTRAL CONNECTICUT REGIONAL WATER AUTHORITY. This bill is effective from passage.
SB 352 PA 18-33	AN ACT EXTENDING THE MORATORIUM ON APPROVAL OF A CERTAIN NUMBER OF PROGRAMS OF INDEPENDENT INSTITUTIONS OF HIGHER EDUCATION. This bill takes July 1, 2018.
HB 5433 PA 18-26	AN ACT CONCERNING MINOR AND TECHNICAL CHANGES TO THE TAX AND RELATED STATUTES. This bill has various effective dates.
HB 5429 PA 18-25	AN ACT CONCERNING INCREASED PENALTIES FOR CERTAIN CIGARETTE AND TOBACCO TAX VIOLATIONS, A CONTINUING EDUCATION OPTION FOR CERTAIN EMBALMERS OR FUNERAL DIRECTORS AND THE IMPOSITION OF THE TOBACCO PRODUCTS TAX ON CIGARS. This bill takes effect July 1, 2018.
SB 150 PA 18-38	AN ACT PROVIDING PROTECTIONS FOR CONSUMERS APPLYING FOR REVERSE MORTGAGES. This bill takes effect October 1, 2018.
HB 5219 PA 18-20	AN ACT ALLOWING APPLICANTS FOR SECURITY OFFICER LICENSES TO WORK AS SECURITY OFFICERS. This bill takes effect July 1, 2018.
HB 5454 PA 18-121	AN ACT CONCERNING NINETY-DAY PERMIT TURNAROUND TIMES FOR THE DEPARTMENT OF ENERGY AND ENVIRONMENTAL PROTECTION. This bill is effective from passage.

As of this date, the Governor has signed forty-five (45) bills of the 2018 Regular Session.
