Work hours are Monday through Friday, 8:00 a.m. to 4:00 p.m., 7 hours/day, 35 hours/week. We anticipate having one full time opening with no over-time.

Suggested duties may include, but not limited to; field preparation, watering, fertilizing, planting, weeding, irrigating, equipment and property maintenance and mowing.
