This Project consists of two solar PV systems that will reside on the grounds of Manson Youth Institution and the Cheshire Correctional Institution. The Cheshire Correctional Institution solar PV System, located at 900 Highland Ave, will consist of roughly 5,100 solar panels with a capacity of approximately 1.9 megawatts (MW). This will be a ground mounted system located within an existing maintained field in the southwest portion of the property. The solar array footprint will occupy roughly 6.5 acres.

The Manson Youth Institute solar PV system, located at 42 Jarvis St, Cheshire, is of similar scale. This system will consist of roughly 4,600 solar panels with a capacity of approximately 1.9 MW. This will be a ground mounted system with arrays located at two different parts of the property, occupying a total of roughly 5.7 acres

Project Description:

This Project consists of five solar PV systems that will reside on the grounds of Willard-Cybulski Correctional Institute, Osborn Correctional Institution and Enfield Correctional institution. Included in this submission are the proposed site plans for each system. Although some systems abut one another and share the same perimeter fence line, each of the five solar PV systems are designed to operate independently from one another.

The ground mounted PV systems of Robinson A, Robinson B and Enfield are all proposed to be on the South side of Enfield Correctional Institution at 289 Shaker Rd, Enfield. These three PV systems abut each other creating one ground mounted solar array. Robinson A consists of approximately 304 solar panels with a capacity of approximately 92 kilowatts (kW). Robinson B consists of approximately 704 solar panels with a capacity of approximately 212 kW. Enfield consists of approximately 608 solar panels with a capacity of approximately 205 kW. Combined these three PV systems will occupy an area that is roughly 1.3 acres of an existing field. This proposed location is roughly 1,050 Linear Feet (LF) West of a grassland bird mitigation area.

The ground mounted PV system of Willard is proposed to be built on the South side of Enfield Correctional Institution. The PV system consists of approximately 1,944 solar panels with a capacity of approximately 625 kW. This system will be electrically connected into the Willard Building of the Willard-Cybulski Correctional Facility located at 391 Shaker Rd, Enfield. This PV system will occupy an area of roughly 2.5 acres. The proposed location is roughly 750 LF West of a grassland bird mitigation area.

The ground mounted PV system of Osborn is proposed to be built on previously farmed land located on the North West side of Osborn Correctional Institution. This PV system consists of approximately 4,830 solar panels with a capacity of approximately 1.8 MW. The total area of this PV system is roughly 5.7 acres. This proposed location is roughly 65 LF East of a grassland bird mitigation area.

4. Notice of Scoping for Suffield Wildlife Management Area Prescribed Burn

Address of possible location: 510 Point Grove Road, West Suffield CT 06093

Municipality where proposed action might be located: Suffield CT

Project Description: The Connecticut Department of Energy and Environmental Protection (DEEP) Wildlife and Forestry Divisions aim to manage vegetation using prescribed fire within portions of Suffield Wildlife Management Area (Suffield WMA), a state-owned natural area managed for wildlife conservation and wildlife-based recreation. Burning operations may occur annually. In 2022, DEEP proposes to conduct a prescribed burn during Feb 1 to April 15, 2022, when weather conditions permit. This prescribed burn will encompass 49.5 acres of grassland and will take one or two days to complete. The operation will be conducted under the direction of qualified fire professionals when weather and atmospheric conditions allow. The Suffield WMA will be closed to the public during the operation of the prescribed fire. Prior to the burn, the Suffield Fire Department and the Town of Suffield will be notified. A notice will be sent to the Town Hall on the day of the burn and signage will be posted at the Suffield WMA to notify the public.

The overall goal of prescribed fire in all units is to sustain and enhance sandplain grassland habitat, an underrepresented natural community that many wildlife Species of Greatest Conservation Need rely on to survive and reproduce. Prescribed fire is an effective management tool to maintain and enhance grassland habitat. Following prescribed burn, and the resulting consumption of the aboveground biomass, new vegetation will grow soon after and the entire site will be revegetated. Expected long-term changes to vegetation within burned areas is an increase in percent composition of warm season grasses, an increase in percent composition of exposed mineral soil, and a decrease in percent composition of forbs and woody trees/shrubs. The project site will remain an undeveloped natural area following management activities. Prescribed burning may occur here during August 15 to April 15 annually; the public notification process will remain unchanged in future years.
