FIREFIGHTER TESTING ANNOUNCEMENT

PLEASE READ THIS ENTIRE ANNOUNCEMENT & PRINT FOR REFERENCE

The City of Bristol is accepting applications for Firefighter testing to establish an eligibility list to fill future vacancies. Initial testing requires possession of a CPAT Certificate (physical ability test), and successful completion of a written and oral examination. Additionally, a medical exam including a workfit assessment and drug screen, and background investigation are required prior to hire. *Written Exam details to follow after the application deadline.*

NOTE: To gain entrance to the Written Exam scheduled for the Summer 2021, you are required to present a CPAT CERT issued on or after June 1, 2020.

SALARY: \$53,964 upon hire. (During first year of employment the annual wage increases @ 6 month & 1 year anniversary.)

MINIMUM QUALIFICATIONS AT TIME OF APPLICATION:

•Must be 18 yrs of age •High School Diploma/GED •United States Citizen •Valid Driver License

RESIDENCY POINTS: 5 points will be added to the final passing score (maximum score = 100 points) for eligible residents. Must be domiciled in the City of Bristol as of the closing date for applications, May 1, 2021; AND must maintain residency throughout the testing process.

Upload the [Firefighter Residency Form](#) along with supporting documents when you complete the online employment application; OR you can **mail** the required paperwork to City of Bristol Human Resources Dept., 111 N. Main St., Bristol, CT 06010 **postmarked by May 1, 2021**, OR **bring** the completed paperwork to Human Resources **by 5:00 p.m. on May 1, 2021.**

VETERANS POINTS: 5 points will be added to the final passing score (maximum score = 100 points) for eligible veterans. See [Firefighter Testing Summary](#) for details.

CPAT Certificate (Candidate Physical Ability Test) is required & presented at the written test date. Bristol requires a **CPAT CERT** be **issued on or after June 1, 2020.**
