# FIREFIGHTER Testing Announcement

**PLEASE READ THIS ENTIRE ANNOUNCEMENT & PRINT FOR REFERENCE**

The City of Bristol is accepting applications for Firefighter testing to establish an eligibility list to fill future vacancies. Initial testing requires possession of a CPAT Certificate (physical ability test), and successful completion of a written and oral examination. Additionally, a medical exam including a workfit assessment and drug screen, and background investigation are required prior to hire.

**NOTE: To gain entrance to the Written Exam scheduled for the Fall 2018, you are required to present a CPAT CERT issued either through CPAT's "One & Done Summer 2018 sessions" or "Fall 2018 session".**

**RESIDENCY POINTS:** 5 points will be added to the final passing score (maximum score = 100 points) for eligible residents. Must be domiciled in the City of Bristol as of the closing date for applications, July 28, 2018; AND must maintain residency throughout the testing process.

**Upload** the **Firefighter Residency Form** along with supporting documents when you complete the online employment application; OR you can **mail** the required paperwork to City of Bristol Personnel Dept., 111 N. Main St., Bristol, CT 06010 **postmarked by July 28, 2018**.

**VETERANS POINTS:** 5 points will be added to the final passing score (maximum score = 100 points) for eligible veterans. See [Firefighter Testing Summary](#) for details.

**SALARY:** \$49,336 upon hire, \$52,826 @ 6 months, \$56,336 @ 1 year; \$64,344 @ 2 years
