Commission on Fire Prevention and Control receives donation of Honda alternatively fueled vehicle

At their January 31, 2006 meeting, the Commission on Fire Prevention and Control received the donation of a 2001 Honda Civic GX fueled by compressed natural gas.

The vehicle will be used exclusively for firefighter training at the Connecticut Fire Academy. Representing American Honda Motor Company Inc. were Roger Quandt, Assistant Zone Manager for Honda, John Larabee, Founder and President of Manchester Honda, and Craig Peters from Manchester Honda.

Representing the Commission was Chairman Peter Carozza, Jr. Manchester Honda is the area Honda dealer certified for compressed natural gas powered vehicle repairs.

This vehicle will be a valuable asset to the Connecticut Fire Academy in demonstrating safety concerns associated with alternatively fueled vehicles during firefighter training scenarios.

It is anticipated that the vehicle will be used in the recruit firefighter program, car fire, vehicle extrication, and alternatively fueled vehicle classes.



The future promises more vehicles fueled by other alternative fuels like hydrogen, stored and regenerated electricity, and fuel cells.

Firefighters will learn how to extinguish fires and safely remove occupants from vehicles powered nontraditionally.

2006 Fire Act Grant Writing Workshops Held throughout Connecticut

The Commission on Fire Prevention and Control’s Connecticut Fire Academy, and the Department of Homeland Security held six (6) separate “Grant Writing Workshops” throughout the state on February 14 thru 18, 2006.

The six workshops were identical, so attendance at any one site was sufficient.

There were a total of 133 people who attended this workshop throughout the state.

Bob Waters, Fire Program Specialist was available for questions and answers. He also explained changes to expect in 2006.

Symtron Train-the-Trainer

We will be offering an initial training program for instructors wishing to become operators of the Symtron Live Fire Training Equipment. The program will be held here at the CFA on June 10th and 11th and will be taught by Instructor John King.

New burn operators are required to attend both days of training (8:30 AM-4:30 PM) and then to spend a day during a live burn operating the system with a experienced operator to demonstrate the knowledge skills and abilities required to be certified as a burn operator. All burn operators are required to attend an annual refresher training program to continue to be on the list of active operators. The training program covers the operation of the pump house, tank farm, burn building,

and outside props. The burn building is computer controlled so familiarity with windows based computer programs is beneficial.

All initial and refresher training for the Symtron equipment is voluntary but there is a constant need for burn operators throughout the year. I currently have live burns scheduled for every month for the rest of the year with new requests being received on a regular basis. Live burns are conducted on weekdays, weekends and evenings so we need operators for all these time periods. 2006 Assistance To Firefighters Grants

Beginning March 6, 2006, at 8:00 a.m. eastern standard time, the Department of Homeland Security (**DHS**) will begin accepting applications for Assistance to Firefighters Grants (**AFG**).

The deadline for receipt of the AFG "fire grant" applications is 5:00 p.m. eastern daylight time on April 7, 2006. AFG applications are automated and accessible via the AFG web site: www.firegrantsupport.com.

The web site contains important information on the AFG, including the FY2006 funding priorities and program guidance, a web based tutorial on the application process, a listing of frequently asked questions, and other materials.

Fire departments that have questions regarding this grant opportunity should contact the Help Desk at 1-866-274-0960 or at firegrants@dhs.gov.

During the application period, Help Desk hours will be from 8:00 a.m. to 8:00 p.m., Monday through Friday, and on Saturdays from 8:00 a.m. to 4:30 p.m. Additional help desk hours may be added if demand is high.



2006 Firefighter Safety Stand Down

Fairfax, VA...Building on the success of the first National Firefighter Safety Stand Down in 2005, the Board of Directors of the International Association of Fire Chiefs (IAFC) has called for the “Second Annual Stand Down” to be held starting Wednesday, June 21, 2006, and continued until all personnel and duty nights have been covered. Fire departments are urged to save this date and plan to participate in the event.



Last year, an estimated 10,000 fire departments participated in the National Firefighter Safety Stand Down. Activities were posted on the IAFC and its partner's Web sites.

The IAFC Safety, Health and Survival Section will be updating the recommended activities, and when those details are developed, they will be distributed. Sadly, 106 firefighters died in the line-of-duty last year. Since many of the accidents occurred in department vehicles, we have decided to focus this year's stand down on emergency vehicle safety, where we can have the most impact.

We must take dramatic steps to reduce the alarmingly high firefighter death and injury rates,” said IAFC President Chief Bill Killen. “While firefighter safety must be part of everyday life in the

fire service, the “Safety Stand Down” raises awareness of the issue and calls national attention to the unacceptable number of firefighter line-of-duty deaths”.

Once again, the IAFC will be reaching out to other fire service organizations to join forces and involve the entire fire service in the event. Last year, 19 organizations partnered with the IAFC for the first stand down.

The NIMS Integration Center's five most frequently asked questions, which are posed primarily via e-mail, focus on required NIMS training, lost or delayed NIMS/ICS training certifications

from the Emergency Management Institute, and NIMCAST temporary passwords.

In the interest of providing the information most relevant to our audiences, we have decided to repeat those questions and our answers in this NIMS Alert.

We also urge you to check our FAQ site, which is directly accessible from the NIMS Homepage at www.fema.gov/nims; it is updated frequently based on your questions.

Office of the Director of Training

Folks:

A new feature has been added to the Connecticut Fire Academy. Wireless internet access has been installed throughout the facility, but works most effectively in the upstairs and in the public areas such as the multipurpose room (cafeteria), auditorium, and classrooms. In the future, additional transmitters will be installed to yield facility-wide coverage. This means the complete administrative building and classrooms, not the training grounds.

We have added this convenience to become more user friendly for our seminar speakers and people that rent the facility. Another long standing request has been answered by supplying our lodging guests, primarily recruit students, with internet access for e-mail accounts etc. If you have a wireless equipped computer it will find the network and you may connect to the internet.

Shortly, Adjuncts will be receiving copies of the following by email:

- ☑ State Code of Ethics for Public Officials and State Employees
- ☑ Internet Acceptable Use Policy
- ☑ Electronic Mail Acceptable Use Policy

These must be reviewed and acknowledged to Carolyn Underwood, who is our new personnel contact, at the Department of Administrative Services.

Another long awaited activity is the employment of some new Adjunct instructors. Some of you may have already learned of our advertisement located on the **DAS** website. It is the beginning of our intake process to select upwards of thirty (30) new Adjuncts. To ensure selection of the “best of the best” we are actively soliciting candidates.

Current, PSAs (contracted employees) will be given the opportunity to interview and build upon their current activities as a Connecticut Fire Academy contractor. Instructors and Program Coordinators are encouraged to supply the Director of Training with comments related to observed contractor performance in the field. This will be considered during the interview process.

Ultimately, the use of contracting will be held to CPAT specific assignments and occasional random jobs that require assistance from outside the Adjunct instructor ranks.

The process of Adjunct selection will include the delivery of a practice lesson assigned by the Academy. We invite existing instructors to participate in the interview process and help us role play within the class delivery and interview candidates.

Once an interview schedule is posted it will be shared via the instructor notification system. This will be an unpaid activity.
