Conference Presenters

Tonya Hoover USFA – NFA

Tonya Hoover is the Superintendent of the U.S. Fire Administration's National Fire Academy (NFA). She was named to this position in May 2017. As Superintendent, Ms. Hoover provides leadership for the NFA, which focuses on enhancing the ability of fire and emergency services and allied professionals to deal more effectively with fire and other emergencies.

Deanna Harrington Arvada CO FD

Deanna Harrington, a 16 yr member of the fire service, is the Battalion Chief of the Community Risk Reduction Division In Arvada CO. She is an active member of the Colorado Risk Reduction Network, is a member of the IFSTA *Fire and Life Safety Educator, 4th Edition* committee, an instructor at the National Fire Academy and has engaged in a number of projects

through Vision 20/20. She will showcase some successful efforts in CRR in Colorado.

Michael Spaziani FM Global

Michael Spaziani is the Manager of Fire Service Programs at FM Global. He will provide an overview of what resources are available from FM Global.

Terrence Ferrarotti CCSU FD

Greg joined the Tennessee State Fire Marshal's Office in 2008, and held a variety positions before accepting his current role in January 2017.
