# CHRO ATTORNEYS HAVE A PRESENCE AT THE CIVIL RIGHTS CONFERENCE SPONSORED BY THE U.S. DEPARTMENT OF JUSTICE

The U. S. Department of Justice held its first annual **Civil Rights Conference** at Quinnipiac Law School on March 16, 2011.



CHRO Attorneys Cheryl A. Sharp and Michelle Dumas Keuler were invited to speak at this conference that featured a heartfelt presentation by the father of Matthew Sheppard, the young college student who was fatally attacked because of his sexual orientation. Attys. Sharp and Keuler provided information about the CHRO's complaint and public hearing processes to a capacity crowd. Atty. Sharp served on the Americans with Disabilities Act

panel and the antibullying panel. Attorney Keuler was called on to answer questions about the state protections for of alleged victims housing discrimination, during the panel discussion on Housing. Exec. Director Referees Brothers, Thomas C. Austin, Jr., Donna M. Wilkerson Brillant and J. Allen Kerr also attended. U.S. Attorney David Fein's Office and Assistant U.S. Attv. Ndidi have Moses recently forged partnership with the CHRO on several outreach projects and civil rights cases aimed addressing illegal discrimination.

#### PUBLIC HEARING

In this fiscal year (fy) 8/1/10to 3/30/11 the referees have conducted 129 conferences, 5 hearings in damages, and 5 public hearings. discrimination cases have been certified and whistleblower retaliation cases have been filed. Thirtythree discrimination cases and 14 whistleblower cases have been closed. The settlement figures for discrimination cases this fy total \$80,000.00. These do include figures not confidential amounts. The total awards via final decision in a discrimination case is **\$140,473**.
