Notice is hereby given that, pursuant to Section 38a-474 of the Connecticut General Statutes, a public hearing will be held before the Insurance Commissioner of the State of Connecticut on Thursday, December 5, 2019 at 9:00 a.m. 153 Market Street, (6th Floor, Conference Room 600), Hartford, Connecticut.

This hearing will be held to consider the rate increase filing made by United American Insurance Company on its Medicare supplement insurance policy forms. 
