### Notice of Public Hearing/Medicare Supplement Insurance Rate Increase Request Docket Number LH 19-58

Notice is hereby given that, pursuant to Section 38a-474 of the Connecticut General Statutes, a public hearing will be held before the Insurance Commissioner of the State of Connecticut on Thursday, July 18, 2019 at 9:00 a.m., 153 Market Street, (6<sup>th</sup> Floor, Conference Room 600), Hartford, Connecticut.

This hearing will be held to consider rate increase filings made by Central States Health & Life Company of Omaha on its individual and group Medicare supplement insurance policy forms. The hearing will be held in accordance with the authority granted to the Insurance Commissioner under Sections 38a-474 and 38a-495a of the Connecticut General Statutes and Sections 38a-474-2 and 38a-495a-10 of the Regulations of Connecticut State Agencies.

The rate increase filings that will be considered at this public hearing concern the company's individual and group Standardized Medicare supplement insurance policy forms.


