### **ORDER TO RECHEDULE PUBLIC HEARING**

The coronavirus disease 2019 (COVID-19) outbreak in the United States including Connecticut continues to severely impact businesses, supply chains, workforces and consumers. The COVID-19 disease has led to disruptions to transportation, limitations on social and business gatherings, imposition of quarantines, self-isolation and social distancing policies by government and businesses such as working remotely and use of virtual-only meetings and teleconferencing in lieu of in-person meetings in order to help slow the spread of the virus and minimize the resulting serious illness or death.

On March 2, 2020, I, Andrew N. Mais, Connecticut Insurance Commissioner, issued an order pursuant to Conn. Gen. Stat. §38a-156a for a public hearing to be held on May 18, 2020 concerning the proposed plan of reorganization of Connecticut Medical Insurance Company.

On March 25, 2020, Connecticut Governor Ned Lamont, in order to further prevent the potential public threat and spread of COVID-19 to any person who might participate in the process of submitting, reviewing, hearing, discussing, deciding, or appealing an agency, board or commission decision, action, or related activity, and to allow for delays and unavailability caused by disruptions related to the COVID-19 pandemic, issued Executive Order No. 7M which authorizes each commissioner of this State to extend, as they deem reasonably necessary to respond to the COVID-19 pandemic or its effects, any statutory or regulatory time requirements, hearings, or other time limitations or deadlines pertaining to matters under their respective jurisdiction, functions or powers for a period not to exceed 90 days.

Therefore, in light of the current COVID-19 situation, I find that it is in the public interest and consistent with efforts to slow the spread of the virus and minimize serious illness or death that, pursuant to Executive Order No. 7M, I hereby order the public hearing in this matter be rescheduled to **August 14, 2020** at 9:00 a.m. in room 701 at the Connecticut Insurance Department, 153 Market Street, 7th Floor, Hartford, CT.

All other provisions of the Notice of Public Hearing issued on March 2, 2020, shall remain in effect.

### NOTICE OF PUBLIC HEARING CONCERNING THE PROPOSED PLAN OF REORGANIZATION OF CONNECTIUT MEDICAL INSURANCE COMPANY DOCKET NO. EX 20-24

Notice is hereby given that the Insurance Commissioner of the State of Connecticut will conduct a public hearing on May 18, 2020 at 9:00 a.m. in room 701 at the Connecticut Insurance Department, 153 Market Street, 7<sup>th</sup> Floor, Hartford, CT. The hearing will be conducted pursuant to section 38a-156a(c)(1) of the Connecticut General Statutes; and sections 38a-8-1 through 38a-8-104, as applicable, of the Regulations of the Connecticut State Agencies. Persons interested in being designated a party or intervenor should consult sections 38a-8-48 and 38a-8-49 of the Regulations of the Connecticut State Agencies.

The public hearing is being held on the question of granting approval pursuant to section 38a-156a(c)(3) of the Connecticut General Statutes of the application filed by Connecticut Medical Insurance Company, dated January 31, 2020 (the "Application"). The Application requests the Insurance Commissioner's approval, as required by section 38a-156a(c)(3) of the Connecticut General Statutes, of the proposed reorganization of Connecticut Medical Insurance Company as a stock insurance company that will be indirectly owned by a mutual holding company (the "Proposed Reorganization").

The Proposed Reorganization will be effected pursuant to the terms of the Plan of Reorganization of Connecticut Medial Insurance Company (the "Reorganization Plan"). The official record of this proceeding, which includes a copy of the Application and the Plan, is on file with the Connecticut Insurance Department, 153 Market Street, 7th floor, Hartford, Connecticut, and is available for public inspection during regular business hours.

At the public hearing, representatives of Connecticut Medical Insurance Company as well as any other party or intervenor designated by the Insurance Commissioner pursuant to sections 38a-8-48 and 38a-8-49 of the Regulations of the Connecticut State Agencies, and his appointed hearing officer, will appear and be heard concerning the consideration by the Insurance Commissioner of the Application. The public will, at the hearing officer's discretion and in accordance with section 4-177c (b) of the Connecticut General Statutes, be given an opportunity to comment on the Application with respect to the issues to be considered by the Insurance Commissioner. Written statements may also be submitted during the public comment portion of the public hearing or filed with the Insurance Department prior to the close of business on May 15, 2020, by mailing or delivering such statements to the Connecticut Insurance Department, P.O. Box 816, Hartford, CT 06142-0816, Attention: Jared T. Kosky, Esq.
