Notice is hereby given that, pursuant to Section 38a-474 of the Connecticut General Statutes, a public hearing will be held before the Insurance Commissioner of the State of Connecticut on Tuesday, November 20, 2018 at 9:00 a.m., 153 Market Street, (6th Floor, Conference Room 600), Hartford, Connecticut.

This hearing will be held to consider a rate increase filing made by Combined Insurance Company of America on its Medicare supplement insurance policy forms. The hearing will be held in accordance with the authority granted to the Insurance Commissioner under Sections 38a-474 and 38a-495a of the Connecticut General Statutes and Sections 38a-474-2 and 38a-495a-10 of the Regulations of Connecticut State Agencies.

The rate increase filing that will be considered at this public hearing concerns the company's individual Standardized 2010 and 1990 Medicare supplement insurance policy forms.
