Notice is hereby given that, pursuant to Section 38a-474 of the Connecticut General Statutes, a public hearing will be held before the Insurance Commissioner of the State of Connecticut on Tuesday, September 25, 2018 at 9:00 a.m. 153 Market Street, (6th Floor, Conference Room 600), Hartford, Connecticut.

This hearing will be held to consider the rate increase filings made by Bankers Life and Casualty Company on its Medicare supplement insurance policy forms.
