Thank you for your email.

Given Attorney Green's clients have a pending request for party status that cannot be taken up prior to the scheduled public hearing on Tuesday, a continued remote evidentiary hearing session for Docket 502 has been scheduled for **Tuesday, August 31, 2021 at 2 PM.**

We will issue a formal memo for the continued evidentiary hearing session after the hearing on Tuesday that will include a revised schedule for issuance of interrogatories and submission of pre-filed testimony, exhibits and responses to interrogatories, along with instructions for access to the continued evidentiary hearing session. As you know, pre-filed testimony, exhibits and responses to interrogatories are due one week before a scheduled hearing, so the deadline would be August 24, 2021 for the August 31, 2021 continued evidentiary hearing session. This would apply to all parties and intervenors.
